Article 2 – All rights under the UNCRC should be afforded to all children without discrimination

Article 3 – Adults should make decisions that are best for children

Article 4 – The Government should protect children and their families

Article 5 – Family is responsible for protecting children's rights

Article 6 – Children have a right to life, survival and development

Article 7 – Children have the right to a name and a nationality

Article 8 – Children have the right to an identity

Article 9 – Children have the right to live with their parents and a family that love them, unless it is bad for them

Article 10 – Children have the right to live in the same country as their parents

Article 11 – Children have the right to be protected from kidnapping

Article 12 - Children have the right to a voice and for their voice to be listened to

Article 13 – Children have the right to get information and share information in whatever way they want, unless it offends others

Article 14 – Children have the right to choose their own religion

Article 15 – Children have the right to choose friends and to be part of groups, unless it offends others

Article 16 – Children have the right to privacy

Article 17 – Children have the right to receive information that helps them and is not harmful

Article 18 – Children have the right to be raised by their parents, unless it is bad for them

Article 21 – Children who are adopted or fostered have the right to care and protection

Article 22 – Children who are refugees have the right to special protection

Article 25 – Children in care have the right to appropriate living conditions

Article 26 – Children who are poor or in need have the right to help from the Government

Article 30 – Children have the right to practice their own culture, religion and language

Article 31 – Children have the right to play and rest

Article 32 – Children have the right to protection from work that harms them or is bad for their health or education

Article 36 – Children have the right to be protected from being exploited

Article 37 – Children have the right to be protected from being punished in cruel or harmful ways

Article 38 - Children have the right to be protected from war

Article 39 – Children have the right to help if they have been badly treated, hurt or neglected

Article 40 – Children have the right to be treated fairly in the justice system


Article 41 – Governments can't take the rights of the UNCRC from children, they can only add to them
